Sir,

Gandhi Natha Rangaji Homoeopathic Medical College, 13, Budhawar Peth, Jain Boarding Campus, Balives, Solapur, Maharashtra- 413002 is functional since 2000 has applied for permission for sanction of BHMS course with 50 seats including for the academic year 2024-25. The College has submitted the Part 1 information in which the entire functional profile has been narrated. The Medical Assessment and Rating Board has examined the profile of the College as to whether the college fulfils the Minimum Essential Standards to be fulfilled as per the prevailing regulations under clause 28 of NCH Act 2020.

On careful examination of the Part 1 information and inspection conducted on 23/7/2024 & 24/7/2024 the following shortfalls are seen;

1. Miscellaneous

- Adhaar enabled biometric attendance system (AEBAS) is not implemented. This may be enabled within a period of one month.

2. Inspection Remarks

- No patients are seen at 10:00 a.m whereas it is noted that patients were registered in advanced in the OPD registration.
- No old IPD patients in bed but around 6 new patient were admitted in the hospital, by 5p.m.
- Total no of OPD patient is 163 and IPD is 10 on the day of inspection.
- No register book in X-RAY lab & ECG rooms.

IPD and OPD case records should be maintained with demographic details of the patient such as Name, Age, Sex, Address, Phone number, etc. Diagnosis of the case shall be recorded as per ICD 11 criteria. All follow up attendance should be recorded on the case records. Case sheets shall be maintained with complete case history, analysis and evaluation and repertorisation and made available in Medical Record Room for academic purpose of students and follow up of patients

Considering the above observations and facilities available, MARBH has decided to issue **Conditional permission to Gandhi Natha Rangaji Homoeopathic Medical College, 13, BudhawarPeth, Jain Boarding Campus, Balives, Solapur-413002 Maharashtra for continuing BHMS Course with intake capacity of 50 seats including for the academic year 2024-2025.**

All deficiencies noticed shall be rectified within a period of one month and the compliance report shall be submitted for verification.

It is further to mention that all admissions shall be made for NEET qualified candidates only. It is further informed that minimum 15% of undergraduate seats of the permitted intake capacity of 50 UG seats shall be treated as All India Quota. The counseling for seats under All India Quota shall be conducted by respective counseling authority of State/UT Govt. as designated by Central Government for the A.Y. 2024-25 and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned Counseling Authority of that State/UT.

The Category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board.

Permission to college can be withdrawn or denied in the subsequent year if college is found deficient in compliance to MSR 2013 anytime during the academic year.


